

## First Tech's "Uncomplicate Your Life Sweepstakes" Official Rules

No purchase or obligation necessary. Non-purchase entries have an equal chance of winning.

**1. To Enter.** The Sweepstakes are taking place on Facebook and Twitter so you'll need to [fan us](#) or [follow us](#) to participate. Participants may also mail in an entry form.

**Twitter-** Become a follower of @FirstTechCU and do any of the following:

- ▶ Send us an @reply with your own uncomplicated tips
- ▶ Retweet one of our uncomplicated tips of the day
- ▶ Include the hashtag #UYL in your tweets

**Facebook-** Become a fan of First Tech on Facebook and do any of the following:

- ▶ Take our Facebook quiz
- ▶ Invite friends to take the quiz
- ▶ Post a tip on our wall on how to uncomplicate your life.

Entries limited to five entries per channel, per individual account, per day.

To enter without purchase or obligation, print your name, address, city, state, zip, day and evening phone number and the words "Uncomplicate Your Life" on a 3" x 5" card and bring to any First Tech Credit Union branch location or mail it to First Tech Credit Union's Uncomplicate Your Life Sweepstakes, PO Box 2100, Beaverton, OR 97075. Entry will be eligible for the weekly drawing in which the card is received.

**2. Eligibility.** The Sweepstakes is open to all legal residents of the 50 United States and the District of Columbia, eighteen years or older, as of October 26, 2009. Employees of First Tech Credit Union, its affiliates, their prize suppliers, and the immediate families (spouse, and parents, siblings, children, and each of their spouses) and persons living in the households of each of these individuals, whether related or not are ineligible. Void where prohibited or restricted by law. The drawing is subject to all applicable federal, state, and local laws and regulations.

**3. Drawing.** Each week's entries will be eligible for that week's prize and then removed for all subsequent drawings. Participants must enter each week to be considered for each weekly drawing.

Entries will be accepted beginning Monday October 26, 2009. Each subsequent Monday through December 14, 2009, a weekly random drawing will take place from all eligible entries. One winner each week will receive a prize. Not transferable. Terms and restrictions apply.

Each Monday we will announce what prizes we will give away that week. You will have until 11:59 PST on the following Sunday to enter to win.

**5. Prize Claims.** The winner will be notified by a Direct Message on Twitter, Facebook or by phone, and may be required to complete and sign an Affidavit of Eligibility and Liability Release. If a prize is won by a person who is not of the legal age of majority in the state of residence, the prize will be awarded in the name of the parent or legal guardian. If a prize or a prize notification is unclaimed by the end of the week of the following drawing, or returned as undeliverable, a prize may be forfeited and awarded to an alternate winner. Alternate winners will be selected from a random drawing among all remaining eligible entries.

Additional Terms.** By participating, entrants or, if minors, their parents or legal guardians agree to: a) the Official Rules and decision of the judges and First Tech Credit Union which shall be final in all respects; and b) release, discharge, and hold harmless First Tech Credit Union, their respective affiliates, officers, directors, and employees from any liability, claims, or damages arising out of their participation in the Sweepstakes and the acceptance, use, misuse, or possession of any prize.
